BMODs
 ☐ If you cannot complete your BMOD that you are scheduled for, ask someone to switch to you. You are expected to arrive to help set up if you are the first ones there. If you cannot be there, say something because others might be able to get there to start the concession stand for you. If you are there last, you are expected to clean up. Leave the concession stand ready for the next person for the next day. No one wants to go in the next day and clean up someone else's mess. ☐ Two people on duty work together. One person helps monitor the concession stand while the other monitors the field and sells 50/50. Try to switch each other so both people get to get out. BMODs trump your practices so if practices are important, ask someone to switch you. You have to stay for your whole shift. It is not fair to leave early and let your partner hanging.
